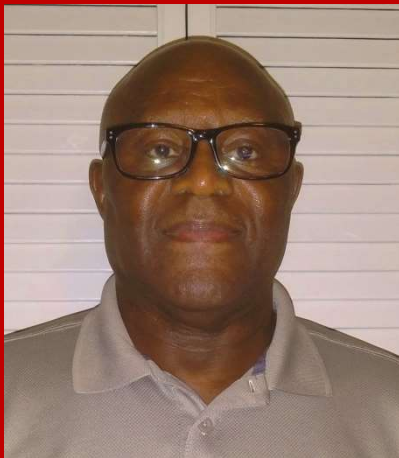
**Kelly Bowers –

Minister**

Faith Formation Ministry is responsible for planning, managing and supporting the faith development of those engaged in our ministry including educational, service and spiritual opportunities for growth.

Finance Minister**

The *Finance Ministry* is responsible for planning, managing and supporting the financial affairs of the congregation, including preparing an annual budget, monitoring loans, insurance and tax relief and oversight of the activities of our Treasurer.

In-reach Minister**

In-Reach Ministry is responsible for planning, managing and supporting the fellowship and stewardship life of the congregation, including implementing and maintaining internal contact and visitation with the membership, encouraging membership participation and involvement in church activities, and coordinating and encouraging members to give of themselves, their time, and their possessions in support of God's work by the church.
